



## Contributor Agreement v. 1.0

Thank you for your interest in contributing to the Laszlo Systems, Inc. ("Laszlo") OpenLaszlo Project. Laszlo can only accept contributions from contributors who have signed a Contributor Agreement. Each person who contributed to code, documentation, or other materials that are contributed to Laszlo must sign an agreement. You only need to sign an agreement once. Laszlo will keep this agreement on file, and you can submit future contributions by stating that they are intended for contribution to the OpenLaszlo project, under the terms of the Contributor's Agreement.

If you have not already done so, please complete and send an original signed Contributor Agreement to Laszlo, Attn: OpenLaszlo Project, 2600 Campus Drive, Suite 200, San Mateo, CA 94403. You may also send it by facsimile to Laszlo at 1-650-358-2790.

Please read this Contributor Agreement carefully before signing it, and keep a copy for your records.

2. The term "Your Contributions" means all of your past, present and future contributions of object code, source code, and documentation to Laszlo, however submitted to Laszlo, excluding any submissions that are conspicuously marked or otherwise designated in writing by You as "Not a Contribution."
3. You assign to Laszlo all copyrights, if any, in and to Your Contributions. You will execute and perform any acts Laszlo requests to implement the letter and spirit of this Agreement, except that you are not required to do anything that would impose an unreasonable time or cost burden on you. To the extent that this assignment is ineffective, you grant to Laszlo a license that is as broad as possible and provides Laszlo with rights as similar as possible to the rights of the copyright owner.
4. Laszlo grants to You an unrestricted, perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable, transferable copyright license to use, make, have made, reproduce, prepare derivative works of, publicly display, publicly perform, transmit, sell, offer to sell, distribute, sublicense, import, and otherwise transfer (internally and externally, in object code and source code form) Your Contributions, and/or derivative works thereof. Laszlo's intention is to grant a license that is as broad as possible and to provide you with rights as similar as possible to the rights of the copyright owner. This license is limited to Your Contributions only.
5. To the best of your knowledge, you represent that, except as disclosed in the submissions of Your Contribution, each of your Contributions is your original creation and does not violate any laws, breaches any contracts, or violates the rights of any person or entity. You represent that Your Contribution submission(s) include complete details of any third-party license or other restriction (including, but not limited to, related patents, trademarks, and license agreements) which are associated with any part of Your Contributions. You agree to notify Laszlo of any facts

or circumstances of which you become aware that would make your representations in this Agreement inaccurate in any respect.

6. You represent that you are legally entitled to assign the rights described in paragraph 3. If your employer(s) have rights to intellectual property that you create, you represent that you have received permission to make Your Contributions on behalf of that employer, or that your employer has waived such rights for Your Contributions to Laszlo.

Except for the representations you've made in paragraphs 5 and 6, Your Contributions are provided AS IS, WITHOUT WARRANTY OF ANY KIND AND DISCLAIMS THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. Similarly, the license back to Your Contributions is provided AS IS, WITHOUT WARRANTY OF ANY KIND AND DISCLAIM THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.
8. This Contributor Agreement shall be governed by the laws of the State of California as such laws are applied to agreements entered into and to be performed entirely within California between California residents and by the laws of the United States. You agree that the United Nations Convention on Contracts for the International Sale of Goods (1980) is hereby excluded in its entirety from application to this Contributor Agreement. In the event of invalidity of any provision of this Contributor Agreement, the parties agree that such invalidity shall not affect the validity of the remaining portions of this Contributor Agreement. This is the entire agreement between you and Laszlo and supersedes any prior agreement, whether written or oral, relating to the subject matter of this agreement.
